#### A MESSAGE FROM YOUR PRESIDENT

Happy Primary Season Everyone! I pray everyone's election prep is going smoothly and that you all have a successful and uneventful election. Remember to reach out to any of us if you have questions, or just need talking off the ledge. We're all in this together.

We have recently received our funding for the Executive Director position and it was posted on February 1, 2024. If you know anyone who is interested, please have them check out our website at <a href="https://www.elections-taea.org">https://www.elections-taea.org</a> for more details on applying. In addition, we will be working on a process for extending grants to counties to attend REO and CERA courses. The grants will include travel expenses. We're very excited about this opportunity to allow some of our smaller counties to pursue these certifications.

Trudy Hancock and I have been working with Jay Williamson to identify legislative priorities and interim projects for 2025 legislative session. Some bills of obvious eminence are SB 924 (combining election precincts in vote center counties) and HB 1217 (extended hours in smaller counties), as well as, bringing back some form of HB 2722 from the 2017 session. That was the bill for professional hardship that allowed an outlet for voters in certain professions to vote by mail. This bill mainly focused on voters in the following categories: truck driver more than 200 miles from home, offshore oil worker, permanent caretaker of someone with a disability.

That's a wrap for right now, but sincerely wishing you all the best in the coming weeks with your election!
